Nominating committee David Teel, Tom Allen and Tom Yows submit the following names for Board of Directors. Each candidate meets all requirements and qualifications for board membership and, if elected, has agreed to serve.

Vicki Deckard (3-year term) currently serves as chairman of the First Central Credit Union's Board of Directors. Ms. Deckard is a Human Resources Generalist with Sherwin Williams and has a degree in Human Relations and Business. She has been a member of First Central Credit Union since 1995.

Richard Hartley (3-year term) served as Senior Vice President of Marketing and Management at Mission Federal Credit Union from 1978 until this retirement in 1997. He is the founder and twice past chairman of the CUNA Marketing Council. Mr. Hartley was chairman of the National University Alumni Association and the Financial Marketing Association. He has been a member of First Central Credit Union since 1997, has served as chairman of the board, and has served as a board member since 2003.

Alfred Solano (3-year term) works as the Sales Manager for Texas Document Solutions where he has been employed since 2009. Alfred graduated from TSTC in 1982 earning his associates degree in Electronics. Actively involved in the Waco community, Mr. Solano serves as an officer for the Cen-Tex Hispanic Chamber of Commerce, as a Director/Officer for the Waco Downtown Development Corporation and as a board member for the Greater Waco Chamber of Commerce.
